#### 1. Introduction

The purpose of measurement is to determine a value of quantity of interest or the measurand. However, when any measurement is made, the measurement process involves the use of standards, work piece, instruments, persons, procedure and environment.

For reliable measurement process, it is necessary to quantify this inherent variation, which is known as the uncertainty of measurement. It is, thus, necessary to not only to understand what measurement uncertainty is, but to learn how to estimate the same and consider its implication in decision based on measurement.

According to clause 5.4.6.2 of ISO/IEC 17025, "Testing laboratories shall have and shall apply procedures for estimating uncertainty of measurement". Further, as per cl. 5.5.1.4 of ISO 15189:2012 Standard on accreditation of medical laboratories, "The laboratory shall determine measurement uncertainty for each measurement procedure in the examination phase used to report measured quantity values on patients' samples. The laboratory shall define the performance requirements for the measurement uncertainty of each measurement procedure and regularly review estimates of measurement uncertainty".

#### 2. Course Objectives

The main objective of this course is:

- ✓ To understand the concept of measurement uncertainty and its implication in measurement
- ✓ To learn how to estimate the uncertainty associated with measurement results of tests & calibration.
- ✓ To practice the estimation techniques through a workshop with live examples so that a participant can perform the calculation at his/her work station.
