#### 1. Introduction

The Quality Manager of any laboratory is the key person responsible for establishing and implementing the management system for effective operations of testing & calibration laboratories. So it is essential that the designated Quality Manager should be well versed with the requirements of ISO/IEC 17025 or ISO 15189 (whichever is applicable).

It is now the requirement of NABL that Quality Manager of the laboratories holding or seeking accreditation from NABL should undergo 4 days training on ISO/IEC 17025.

All the NABL accredited/applicant laboratories of NABL are to comply with above requirements latest by September 2014 and all laboratories applying (first time) for NABL accreditation after 1st November 2012 are required to comply with this requirement which will be verified during Pre/Final assessment by NABL.

Apart from being a mandatory requirement of NABL, this training course is also suitable for Technical Managers of testing/calibration laboratories.

#### 2. Course Objectives

The aim of the course is to provide a concerted and comprehensive training on development & implementation of ISO/IEC 17025 Laboratory Management System (LMS) for building competence of Quality/Technical Manager and other personnel of testing and calibration laboratories.
