<p>1. Introduction</p> <p>Though the revised Standard, ISO/IEC 17025:2017 does not specify a position of Quality Manager, a laboratory holding or seeking accreditation is required to have personnel who, inter-alia, shall implement, maintain and improve the management system, and shall report to laboratory management on the performance of the management system and ensure the effectiveness of laboratory activities. So it is essential that the designated personnel, however named, should be well versed with all the requirements of ISO/IEC 17025:2017 version.</p> <p>Since the Standard does not specify a Quality Manager, NABL's requirement of a 4-day course on ISO/IEC 17025 is construed to apply to all laboratory personnel who implement and maintain the laboratory management system</p> <p>2. Course Objectives</p> <p>The aim of the course is to provide a concerted and comprehensive training on development & implementation of ISO/IEC 17025:2017 Laboratory Management System (LMS) for building competence of all personnel who implement, maintain and improve laboratory activities in testing and calibration laboratories.</p> <p>At the end of the course, participants will be able to:</p> <ul style="list-style-type: none"> ✓ Interpret the requirements of ISO/IEC 17025:2017 and how to apply these requirements correctly ✓ Conduct an effective gap analysis / internal audit / third party audit of LMS ✓ Initiate and drive implementation of LMS in their laboratory in planned and effective manner <p>3.
